Meeting called to order: 6:32 PM

Review of March meeting minutes. CS motioned to accept the minutes. SS seconded. Motion passed.

Any business from the March minutes (not on agenda): ECO AmeriCorps - no word yet on 25/26 host sites.

Event overview: Online speaker series 2025: Good feedback from outsiders - had a few from Scott's workplace attend and enjoy. Nice to see names we don't recognize. We held 3 this year vs 4 in previous years; thoughts on that schedule? Seems fine. Ruby did a great job of choosing the speakers with Sarah's help. We have a running list of topic ideas; please let us know if you have any to add.

Administrative business: Q2 financial review: as expected for staff and grant costs; high on travel, low on projects so far (but summer is main period for these).

End of CA FY20-FY24 review: Jay Land project survey is happening. Six kayaks have been chosen to purchase. A drone has been purchased and staff have tried it out. The images look good. Eliot Cluba is leading student activities in Troy. Working with partners: possibility to put some of our old canoes at Big Falls and have a system for signing them out. We could have a training class in the eddy at the bottom of Big Falls.

Tshirt designs: WS motioned to purchase; JAL seconded, motion passed.

Lindsey Review - summary of feedback; thank you to those who participated! Lindsey appreciated those who completed the review of her performance evaluation. Lindsey asked if we thought there should be an evaluation more than once a year. The response was that we don't need that.

Jay land update. Town working to acquire 194 acre parcel; MRBA to acquire adjacent 10 acre parcel. MRBA voted to buy the 10 acre parcel where the tree nursery will be, even if the town does not pursue the full property. The Jay Selectboard recently withdrew their purchase and sales agreement, so as not to lose their deposit; hopefully their lawyer is working to amend or acquire a new one.
